Guy Carpenter Asia-Pacific Climate Impact Centre Foresees Below-Normal Level of Tropical Cyclone Activity for Australia

Indications Suggest Modest Number of Events in 2009-2010

New York, December 10, 2009

The Guy Carpenter Asia-Pacific Climate Impact Centre (GCACIC), a joint initiative of Guy Carpenter & Company, LLC and the City University of Hong Kong, has published a report predicting the total number of tropical cyclones (TC) affecting the Australia region in general, as well as the Western Australian subregion for the 2009-2010 cyclone season. According to the report, the El Niño/Southern Oscillation (ENSO) predictors suggest below-normal tropical cyclone activity for the remainder of 2009 and into 2010.

SUMMARY OF PREDICTIONS

- For the entire Australian region, ENSO predictors including the NINO4 index, trade wind index and OLR index – forecast a below-normal activity, ranging from seven to nine tropical cyclones with tropical storm intensity or above.
- With the other major indicator, the Indian Ocean Dipole (IOD), in neutral condition, the GCACIC expects below-normal tropical cyclone activity for the Australian region.
- For the western Australian subregion, ENSO and IOD predictors again suggest belownormal tropical cyclone activity, resulting in a final forecast of five tropical cyclones with tropical storm intensity or above.
