The product of a four-year development process and rigorous research, CasCat Version 2 was launched in 2010 with a number of key enhancements, including analysis of the likely distribution of event size and spread, automated scenario generation and the assessment of possible consequences of long-tail casualty catastrophes on an insurer's portfolio.
