## Guy Carpenter makes senior appointments for Europe

She has held several senior analytics and underwriting roles during her career, including with RMS, Willis Re, Nephila, and Tokio Marine before joining SiriusPoint in 2016.

Effective immediately, Enver Karapinar has been named Head of Facultative, Europe, and Riccardo Roveta, has been named Head of Facultative, Europe, London Branch. They will continue to be based in Hamburg and London respectively, and report to Ms. Mélis-Moutafis and Toby Wemyss, Global Head of Facultative.
